FRISBE's purpose is to promote and encourage educational institutions that emphasize scholarship, sportsmanship, moral character and individual responsibility and initiative; all of which we subscribe to and encourage in our students at SMCS.

During the 30 years of operation **FRISBE** has received donations in excess of \$8 million U.S., receipted and donors and made grants to a large number of schools, including qualified Canadian schools. If you wish to make a tax deductible donation to SMCS, please make your donation to **FRISBE** using the enclosed form which requests that their Board make a grant to us. **FRISBE** will issue you a receipt for a United States donation.

The United States Treasury Department, Internal Revenue Service, includes the Friends of Independent Schools and Better Education in its "Cumulative List of Organizations" described in Section 170(c) of the Internal Revenue Code which are except from Federal Income taxes under section 501(c) (3) of the Internal Revenue Code. Contributions and gifts to the Friends of Independent Schools and Better Education are deductible for Federal Income Tax purposes to the full extent permitted by law, Federal Tax Number 91-1216755.
